I understand this authorization may be terminated at the sole discretion of the CAF. This authorization supersedes all previous similar authorizations and is to be retained by the CAF.

I have remitted payment with this application per the level I selected above. I understand that deductions from my account will start on or about the 8th day of the month immediately following the receipt of my authorization at CAF Headquarters.

CAF Membership Monthly Payment Plan Terms and Conditions

- Enrollment in a monthly payment plan for CAF Colonel, Preservation Colonel, or a Life Membership establishes an agreement whereby an agreed-upon amount (generally \$21, \$28, or \$225 respectively) will be paid each month toward a CAF membership, unless otherwise indicated.
- All membership payments are considered donations and are non-refundable and non-transferable.
- CAF Membership payments are drawn on or about the 5th to the 8th of the month. If enrolling in a CAF Membership payment plan between the 1st and the 8th of the month, your second payment will be drawn on or about the 5th to the 8th of the month following enrollment.
- If a monthly payment is not processed successfully, the Membership team will attempt to contact you by phone and by email. If contact is not established within 10 days for payment failure, the CAF reserves the right to move the membership to “Lapsed” status. If payment is not collected for the missing installments within 60 days of the initial failure, the payment plan will be terminated and collected payments will be converted to a donation or applied as payments toward future annual membership dues at the CAF’s discretion.
- If you are a new CAF Colonel or are rejoining the CAF after your membership has lapsed for more than two months, you will be eligible to vote in General Staff and Unit elections only after you have made payments for twelve consecutive months, concluding at least thirty days prior to the election. As an example, if National elections are held on November 1, you will be eligible to vote provided you joined by October 2 of the prior year and remain current.
- If you are an existing CAF Colonel that has switched to the monthly subscription plan, you are eligible to vote in the next General Staff and Unit elections provided you have been a Colonel in good standing for twelve consecutive months.
- Additional guidance on eligibility for voting and holding office for Colonels on monthly payment plans is provided in Unit Manual, Section 2, found in the Colonel login area of the CAF website.
